# NOTIFICATION TO SHAREHOLDERS OF THE FULLY VIRTUAL FIFTY-FIRST ("51ST") ANNUAL GENERAL MEETING ("AGM")

We refer to HLFG's announcement dated 30 September 2020 in connection to its 51st AGM to be held on Friday, 30 October 2020.

In view of the COVID-19 pandemic and in the interest of the health and safety of all stakeholders, the Company has decided to conduct its 51<sup>st</sup> AGM in full virtual manner. All shareholders are welcomed to participate in our 51<sup>st</sup> AGM remotely via live streaming and online voting using Remote Participation and Electronic Voting ("RPEV") facilities by registering online with Boardroom Smart Investor Portal at <a href="https://boardroomlimited.my">https://boardroomlimited.my</a>.

Pursuant to the Guidance Notes on the Conduct of General Meetings for Listed Issuers issued by the Securities Commission Malaysia, there will be no physical AGM venue for a fully virtual general meeting and the only venue involved is the Broadcast Venue where only essential individuals are permitted to be physically present to organise the fully virtual AGM. The Broadcast Venue is strictly for the purpose of complying with Section 327(2) of the Companies Act 2016 which stipulates that the main venue of the AGM shall be in Malaysia and the Chairman shall be present at the main venue of the AGM. No shareholders/proxies will be allowed to be physically present at the Broadcast Venue of the AGM.

## **ENTITLEMENT TO PARTICIPATE AND VOTE**

Only shareholders whose names appear in the Record of Depositors as at 22 October 2020, or their appointed proxy(ies), shall be entitled to participate and vote remotely at the AGM.

### LODGEMENT OF FORM OF PROXY

If you wish to participate in the Meeting yourself, please do not submit any proxy form for the Meeting. You will not be allowed to participate in the Meeting together with a proxy appointed by you.

If you have submitted your Proxy Form prior to the AGM and subsequently decide to appoint another person or wish to participate in the Meeting yourself, please write in to <a href="mailto:cosec-hlfg@hongleong.com.my">cosec-hlfg@hongleong.com.my</a> to revoke the earlier appointed proxy(ies) at least forty-eight (48) hours before the AGM.
